Eligibility for Admission:

4 years B.A./B.Sc. degree in Psychology from a university recognized by the UGC with a minimum of 55% marks in aggregate. For SC/ST category, minimum of 50% marks in aggregate is essential, as per GOI. The candidates who have completed their graduation programme in 3 years of Psychology shall have to pass fourth year Bridge Course or first year of Masters Programme in Psychology with minimum of 55% marks.

Selection Method: MCQ based Entrance Exam followed by Viva-Voce.

Selection Process & Criteria:

Admission to this program is a two-stage process. Candidates must first clear the mandatory entrance examination. Shortlisting for the Personal Interview (PI) round will be based strictly on merit and the minimum cut-off marks achieved in the entrance test. The final selection and offer of admission will be determined by a Cumulative Merit Score, calculated by combining the weightage of the entrance exam marks & performance in the interview.

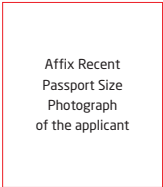
